However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value,

including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The subject tender published on Single tender OEM basis for M/s Intelli planner Software System In dia Pvt. Ltd. Any other bidders, if any, shall be outrightly rejected during bid evaluation.
- 2. Bidder shall NOT QUOTE UNIT RATE and Bidder shall quote Total Price for all BOQ items (detailed at SOW) on Lumpsum basis. Price breakup shall be submitted along with price bid as per EXCEL sheet up loaded.
- 3. NIL DEVIATION: Subject tender is NIL Deviation tender, hence bidder shall not take any deviation ag ainst tender conditions and specifications. Deviation mentioned, if any in the bid or in clarification shall stand withdrawn unconditionally without any additional financial implication.

- 7. LD as per NTPC GCC & SCC.
- 8. All other terms and conditions for the subject contract shall be governed as per NTPC GCC and SCC.
- 9. BTA from NTPC Limited to NML:

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
