- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 1.	The Service Provider should necessarily upload the documents of work completed previou sly; priority will be given to the service provider who had completed the contracts with income tax department.
2.	Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).
3.	The office shall not entertain any claim arising out of mishap, if any that may take place. In the event of any liability/ claim falling on this office, same shall be reimbursed/ indemnified by the Service Provider.
4.	The personnel, if not found working satisfactorily, must be replaced by the Service Provid er immediately.
5.	All existing statutory regulations of both the state as well as the Centre Governments, sha II be adhered to by the Service Provider and all the records maintained thereof shall be av ailable for scrutiny by this office. Any failure to comply with any of the above regulations or any deficiency in service will render this contract liable for immediate termination with out any prior notice.
6.	The person engaged by the Service provider will be in the employment of the Agency/Ser vice provider only. Department/ office will not involve in any dispute between the service provider and workers of the service provider.
7.	Any incidence of inappropriate behavior by any of the DEOs or any interference by them in the official functioning shall be viewed very seriously and may even lead to termination of the contact, if need be.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
