- 7.6 If the Security Deposit is in mode of F.D.R. then the same should be in combined name of G.S.C.S.C.L. & Buyer.
- 7.7 If the Security Deposit is in the form of Bank Guarantee/ePBG, the same should be for the period not le ss than Three months from the date of Purchase Order.
- 7.8 No Interest would be paid on S.D./E.M.D.
- 7.9 Security Deposit will be forfeited in the following cases:

In the event of breach of the terms and conditions of contract by supplier, the corporation will forfeit he security deposit. No interest shall be payable by the corporation on the security deposit.

8. RIGHTS OF G.S.C.S.C.L.:-

- 8.1 The Gujarat State Civil Supplies Corporation Ltd. reserves the right, without giving any reason, to accept or to reject all or any bid including lowest bid.
- 8.2 The Corporation reserves the right, at the time of award of Contract or during the contract period, to in crease the ordered quantity or to decrease the ordered quantity of the quantity offered in the tender witho ut any change in price or other terms and conditions.

- 8.3 Corporation may award work for additional quantity than the quantity of the offered quantity in the ten der by the supplier, at the offered rate and supplier will have to supply this quantity as per the terms of the tender.
- 8.4 If supplier is ready to supply additional quantity that is more than the above quantity of the offered quantity in the tender, at the last offered rate then Corporation will have an option to award the work for the same.
- 8.6 The bidder for such additional quantity shall furnish the necessary additional Security deposit within fift een days from the date of communication of the acceptance of the offer.
- 8.7 If supplier fails in depositing necessary amount as a security deposit for such additional quantity, then action will be taken against the supplier considering that supplier has withdrawn the offer.
- 8.8 If the Corporation does not require to purchase/ or purchase less quantity as per the ordered quantity, because of the change in the state/Central Govt. decision for the implementation of the scheme, the suppli er will neither be entitled to claim any damage for cancellation of the contract nor shall be entitled to initia te legal procedure in the court of law.

9. TRANSIT RISK: -

The supplier is bound to send the goods of prescribed specification at the prescribed purchase center at hi s own risk and cost. The transportation cost and the transits risk are to be borne by supplier.

- 10. DELIVERY SCHEDULE AND PACKING: -
- (10.1) Delivery Schedule will be as under.

- H. The representative of Food research laboratory of forensic science Gandhinagar will take the samples at factory site for quality checking of the goods as per specifications prescribed by G.S.C.S.C.L. and carry out due diligence of quality inspection.
- I. Maximum 1(One) Extension with Penalty will be given in order for maximum period of 7 (seven) working days.

Extension of time limit without penalty will be given only if the reason for delay is attributable to GSCSCL.

- J. G.S.C.S.C.L. will reserve right whether further extension may be given to supplier or not.
- K. The Supplier has to deliver the goods in prescribed packing with net weight at Center of G.S.C.S.C.L. i.e. G.S.C.S.C.L. taluka godown throughout the Gujarat.
- L. Corporation reserves the right to alter the delivery location as and when required.

C. If the Double Fortified Salt stock provided is not as per the norms or any defect is found in the necessar y printing work etc. as per rule, then the legal proceedings will be initiated against the relevant supplier a nd all that stocks has to be taken back by the supplier at his own cost and risk and the corporation will res erve the right to recover the penalty.

D. The nomenclature and dimensional specifications of L.D.P.P. 1 Kilogram pouch & B.O.P.P. - 25 Kilogram bag of [Annexure-I & Annexure-I(A) – Barcode Format]

As per the legal provisions and the Packaging Act, if any details are required to be printed on pouch packing of 1 Kilogram, except this, then it should be added and as per the instructions given by corporation.

- E. The printing work on pouch should be done in three to four colors and its design should be approved fro m corporation.
- F. The Packaging material is liable to change in terms of printing, which shall be communicated to the L-1 after the auction confirmation.
- G. Use of packing materials as per Government Rules and Approval by Government.
- 11. QUALITY: -

11.1 BASIS OF QUALITY

A. Quality of Double Fortified Salt in 1 Kilogram packing should be as per the prevalent rules and regulations of "The Food Safety and Standards Act. 2006 & Food Safety and Standards Rules 2011" and should be a sper the regulations shown in Annexure III-Quality Specification for Double Fortified Salt. The goods except prescribed quality if supplied by the supplier, then the said goods are to be taken back by the relevant supplier at their own expenses and the corporation will not have any liability for its financial loss.

B. The supplier whose proposal is accepted by G.S.C.S.C.L. has to supply the goods

as per rules and regulations and quality specifications prescribed by G.S.C.S.C.L.

- C. Instructions for storage:
- a. 'Double Fortified Salt Offered stock must be stored in hygienic condition place'.
- b. 'Double Fortified Salt Offered stock must be covered with shade& keep away from direct sunlight area. So that Iodine content can be maintained'.

11.2 Sampling process:

To prepare the representative samples of the goods the following procedure will be followed by the Food Research Laboratory.

Except in exceptional cases the sampling process will be carried out within 2(two) day by the representative of Food research laboratory of forensic science Gandhinagar.

A. Sampling is carried out from the offered stock of DFS by randomly selecting the bags in Nos. with same

as the nearest whole number of square root of the nos. of bags offered for sampling.

Sampling is carried by selecting N bags randomly from upper, bottom, middle levels and form periphery of stack as per following IS 14818. Where N is the nearest big whole number of square root of the Nos. of bag s offered for sampling. Select randomly one no. of One kg pouch from each selected 25kg bag and collecting and mix the materials from these selected pouches and prepared required Nos. of samples as per IS 16 232: 2014 or as per IS 7224.

e.g. If offered stock is of 250 MT i.e. 10000 bags –each of 25 kg. Then Nos of randomly selection of bags = $\sqrt{10000} = 100$ bags. Select randomly one pouch from each bag and collect & mix the material of selected pouches and prepared the required Nos of samples by following as per IS 16232: 2014 or as per IS 7224.

- B. The cost of sampling and testing will be borne by G.S.C.S.C.L.
- C. The assaying of the goods will be done at the salt factory premises of the supplier in batch of 250 MT and last batch would be less than 250 MT as per the order quantity given by G.S.C.S.C.L. The assaying agency will be appointed by G.S.C.S.C.L and the representative of the agency will assay the quality of goods as per the prescribed norms.
- D. In case of any circumstances happened, then Request of sampling from leased godown by supplier will be considered if rent agreement is done between two parties as well as G.S.C.S.C.L found it appropriate.
- E. The bags should be stacked in such a manner that, each bag gets representation for inclusion in the representative sample and sample can be drawn easily from upper, middle and lower part of the stack.
- F. Suppliers should give an assurance that if any complain is received from end users regarding quality, the same will have to be resolved as per the decision of G.S.C.S.C.L.
- G. Analysis Report given by Food Research Laboratory of Forensic Science will be considered to be final.
- H. After release of purchase order, tenderer will supply ordered qty. with required quality at the specified c enter of the G.S.C.S.C.L. within stipulated time limit. If the corporation suomoto or on receipt of the compla int about poor quality, the corporation reserves right to do resampling of the commodity already accepted by the corporation.

"Notwithstanding anything contained, corporation at any point of time has the absolute authority to draw a sample, either suomoto or on complaint received in this regard and the sample, either can be tested on its own, without informing to the authorized person of supplier. However if the result of such sample report turned out vastly different than the earlier reports, the corporation reserves the right to blacklist the supplier, all persons connected with it, authorized representative and persons concerned with such authorized representative after giving them an opportunity of being heard."

- I. Supplier should have their own in house quality control lab or certificate of NABL accredited lab should be furnished to the FRL when coming for sampling.
- J. No appeal will be accepted for rejected samples.

Analysis Report given by Food Research Laboratory of Forensic Science will be considered to be final.

12. PFNALTY: -

The supplier will supply order quantity of prescribed quality of goods at designated District center. Howev er, in case, if the supplier fails to complete the delivery of goods in time (including late delivery period) and as per the terms and conditions of the tender document, the G.S.C.S.C.L. reserve the right,

12.1 Not Supplied Quantity.

Failure to Deliver:

If the Supplier fails to deliver the goods/items, either in full or in part, within the prescribed delivery period, GSCSCL shall be entitled, at its sole discretion:

Alternative Procurement:

To undertake alternative procurement of the undelivered portion of the goods/items, at the risk and cost of the Supplier, without cancelling the contract for the goods/items that are not yet due for delivery; or

Cancellation & Substitution:

To cancel the contract, in whole or in part, and, if deemed fit or necessary, to procure the goods/items fro m other sources at the risk and cost of the Supplier.

In either case, any price differential resulting in higher cost to GSCSCL shall be borne entirely by the defau lting Supplier. The defaulting Supplier shall have no claim over the quantity it failed to supply

If the Supplier fails to reimburse the price differential cost, the unpaid amount shall be recovered from the Security Deposit and/or any outstanding bills. In case the recovery remains insufficient, the balance amoun t shall be recovered as arrears of land revenue under the provisions of the Gujarat Land Revenue Code 19 72.

12.2 Replacement and penalty of Goods fail in Cross-verification.

If Cross verification is carried out and it get rejected, the supplier shall replace the stock within 7 working d ays from the date of intimation to the supplier for quality analysis report of FRL. The Corporation will levy penalty @ 2% of the purchase value of goods as well as distributed stock from the respective lot if any from godowns also, in addition to the replacement. However, the corporation has absolute right to increase the rate of penalty. G.S.C.S.C.L. shall issue a show-cause notice to the supplier asking for explanation for rejection of stock. In case the supplier fails to replace the stock, the contract of the supplier shall be cancelled and SD shall be forfeited.

12.3 Batch Failed Penalty

Sample collected from supplier's premises found as per the quality parameters, the goods will be accepte d. If the sample is failed in prescribed quality parameters, the goods will be rejected and rejection charge will be recovered at Rs.14000/- per Batch. and Rs 100/- per MT for 1st rejection, Rs. 200/- per MT for 2nd re jection, Rs 300/- per MT for 3rd rejection and so on... as a penalty by G.S.C.S.C.L.

12.4 Late Delivery Penalty

A. If the supplier fails to supply the salt in given delivery period, penalty at the rate of Rs. 20/- per day per MT on late supplied quantity will be levied by the corporation.

B. In addition to that, If the stock should not be delivered within the 7 working days of QC passed report, p enalty at the rate of Rs. 20/- per day per MT will be levied by the corporation.

12.5 Rejection/ Extension Penalty

A. During a contract, if 3 lots of the suppliers are rejected,

The supplier may be de-barred for the period of three years from the order of debarment for participation in further contracts of G.S.C.S.C.L. auctions or may even be blacklist for the period of one year.

B. In case during a contract, if 30% of monthly Order quantity of the

supplier is rejected, the supplier shall be de-barred from participation in next e-auction for the period of th ree years from the order of debarment and if it will be repeatedly happens then the Supplier shall be black -listed from G.S.C.S.C.L. auctions for the period of one year.

- C. After giving 1 (one) Extension with Penalty in order & if fails to complete it in extension period, the suppl ier shall be de-barred from participation in next e-auction for the period of three years.
- D. During the extension period, if the supplier will not complete the delivery of goods, Tender Clause No. 1 2 (12.1) shall be applicable.
- E. In case of urgent requirements, the G.S.C.S.C.L. reserves the right to grant extension of time with or wit hout penalty subject to condition that supply would be completed during such extended period. Failure to supply the goods during such extended period will amounts to violation of terms and conditions of the cont ract and will result in termination of contract leading application of penal provisions against such supplier as mentioned in 1 and 2 below:
- I. If the supplier fails to supply the goods on account of Force Majeure, the contract for indented quantity stands cancelled between supplier and G.S.C.S.C.L. In such cases G.S.C.S.C.L. will purchase entire quantity by e-auction.
- II. The G.S.C.S.C.L. will not be liable to any risk and cost, whatsoever, consequent upon such cancellation of the one.
- 12.6 Fails to supply more than 50% of PO Quantity.

If the supplier fails to supply more than 50% of the ordered quantity, within stipulated delivery schedule, he will be declared as defaulter and the security deposit of the supplier will be forfeited. The corporation will also recover differential amount on quantity not supplied by the supplier and the corporation purchases the same quantity from alternative sources.

12.7 Fails to supply less than 50% of PO Quantity.

If the supplier fails to supply less than 50% of the ordered quantity within stipulated delivery schedule, the proportionate security deposit of the supplier will be forfeited. The corporation will also recover differential amount on quantity not supplied by the supplier and the corporation purchases the same quantity from alternative sources.

12.8 Not sampled penalty.

Whenever supplier should offer the stock for sampling, it should be available for same qty, should be stack

ed properly, & in prescribed specification or free from insects, for whatever reasons if sampling process couldn't be carried out by FRL, Rs.5,000/- penalty should be levied from supplier.

12.9 No. of Samples increase.

If number of samples (No of sample = ordered QTY/ 250 MT Batch) increases than per batch Rs. 10,000/will be charged by the G.S.C.S.C.L.

12.10 Short Supply Penalty:

In case the goods received at Godown level is Short Supply, in that case the penalty of short supplied quantity is calculated in following manner.

Short Supply penalty amount = (short supplied quantity X Rate of

Purchase value).

12.11 Maximum Penalty Deduction (All Penalties shown in tender clause No. 13) should not be exceed the 10% of Contract value (Purchase value). If penalties of supplier exceed the capping of Maximum penalty a mount (10% of Contract value), disciplinary action (black list/debar) for debarment of supplier for the perio d of three years will be taken by GSCSCL.

13. PAYMENTS:

- 13.1 50% payment will be paid as advance payment within 7 working days from submission of bills along with analysis report and goods receipt issued by taluka godown authorized representative of G.S.C.S.C.L. R emaining 50% payment will be paid after due verification in next 21Working days.
- 13.2 Submission of Minimum 125 MT bill of any batch is Mandatory for Supplier (i.e. 50% bill of 1 batch mu st be submitted)
- 13.3 For the late payment against goods delivered, G.S.C.S.C.L. will not be responsible.
- 13.4 The supplier will present bill along with analysis report issued by authorised representative of concer n laboratory, GeM Invoice, Supplier Invoice, Supplier E-way bill, goods receipt notes from Godown and any other supporting documents attached with bill for payment process.
- 13.5 However, if it is found that offer for sampling of stock is not made within time limit the payment for earlier submitted bills may be postponed or may not be made at the discretion of G.S.C.S.C.L.
- 13.6 Incomplete bills will not be processed.
- 13.7 Only Authorized Representative should deal with the Corporation in respect of payments.
- 13.8 Applicable Tax will be deducted as per norms.

14. FORCE MAJEURE:

I. In any of the force majeure circumstances, namely act of God, natural calamities, fire, Government of Ind ia's policy, Gujarat State Government's policy, any restriction imposed by State/Central Government (excluding any stock limits), strikers or lockout by workers, war, military operations of any nature and blockade s preventing the Seller/Buyer from the performance of the contract, shall be extended for as long as these circumstances prevail. In the event of these circumstances, if the continuation takes place for more than th ree months, the party can have the right to refuse its contractual obligations without title to indemnification of any losses which may thereby sustain. The party which is unable to carry out its contractual obligation s shall immediately advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract.

II. A certificate issued by the respective Chamber of Commerce will be sufficient proof of the existence and time (gross) duration of such circumstances.

15. CANCELLATION OF AGREEMENT: -

I. The supplier, if breaches any condition or clause of the agreement and instructions issued from time to t ime, the G.S.C.S.C.L. is entitled to cancel the agreement and also entitled to demand and recover the loss i neurred to it due to such breach of the agreement.

II. If the Government scheme is closed, due to accidental decision of State/Central Government or any am endment and the proceedings of purchase is stopped by the G.S.C.S.C.L. then the agreement will automatically come to an end for which supplier is not entitled to demand/receive any type of loss amount or cannot initiate any legal proceedings against G.S.C.S.C.L.

16. DISPUTE:-

If any dispute or difference of opinion arises in the agreement, then only the supplier himself or his authori zed agent/representative will represent the same before GeM. The decision of the Managing Director of the Gujarat State Civil Supplies Corporation Ltd. will be considered as final decision and it will be bound to the parties of agreement.

In case of any conflict between the pre-defined General Terms and Conditions of GeM and the present Additional Terms and conditions (ATC), the present ATC shall prevail.

17. GOVERNING LAW JURISDICTION:-

The contract /tender document shall be constituted and the legal relation between the parties hereto shall be determined and governed according to the laws of Republic of India and only courts at Ahmedabad/ Ga ndhinagar shall have the jurisdiction in all matters arising out of/ touching and/or concerning this agreeme nt and parties to this agreement agree to irrevocably submit to the exclusive jurisdiction of those courts for purposes of any such proceeding. The aforementioned exclusive and irrevocable jurisdictions of aforesaid courts are irrespective of place of occurrence of any cause of action pertaining to any dispute be tween the parties.

18. DOCUMENTS CONSTITUTING CONTRACT:

The following documents shall constitute the contract between the Seller and Buyer.

- (1) The Invitation of Bids.
- (2) The terms and conditions of the bidding.
- (3) Bid of the Successful bidder.

(4) Letter/Email confirmation/acceptance issued by the G.S.C.S.C.L. to the successful bidder along with any amendment issued prior to signing of contract.

19. CONTRACT PERIOD:-

Validity of contract will be for the period of five months from the date of work order/contract or full and final payment whichever is later.
